Children First engages families in the community and the courts to promote safe, stable and nurturing living environments for children by providing trained volunteer advocates to children in foster care, as well as supervised visitation and parenting, life skills, and other assistance to families dealing with Georgia's child welfare system. We assisted 300 families with the services we provide in the past year.




